Welcome and Introductions

Meeting called to order @ 5:30pm, introductions were made around the table.

Safety Orientation

Jennifer reviewed safety procedures.

Approval of Minutes

Minutes from the WFP WIWAG June 12, 2014 meeting approved and will be posted to website with the following updates:

Question in regards to minutes - page 2 updates - bulletin item about public safety; will be amended to include trucks. Reviewed accident on Bamfield road, minutes will be updated to improve clarity of accident.

Action Item #1: JD to post minutes to website

WFP Updates:

Kevin Somerville (KS)

Brookfield has divested their shares of Western Forest Products. There doesn't appear to be any front runners in majority shareholders. The last two days have been board meetings (Nov 12th and 13th). Some changes that have occurred are: New Chief Financial Officer; Northern Timberlands operations have consolidated to the Port McNeil office and Nanaimo sawmill has closed. Kevin predicts we might hear more about consolidating and investing in sawmills where it makes financial sense. Key focus is to have shareholder investment. Fibre certainty is a current issue. To have investment, we need fibre certainty. We are not relying on our tenures only. We have secured 100,000 cubic meters, mostly from First Nations, and some from BCTS. There was a blockade after a dispute between a First Nation and BCTS. This has been resolved and we are logging in there again this week. This was a learning experience about how to handle such situations.

Question 1: did Brookfield get back their investment?

KS: Brookfield is a company that turns companies over, they definitely made back their investment and then some.

Question 2: Is the closing of the Nanaimo mill because of the tragedy?

KS: Nanaimo saw mill being shut down is no relation to the incident that occurred their last year. The land was leased from the Nanaimo Port Authority.

Locally we are looking at having our mills in town being able to handle more types of species. Good news for us, because it's a big savings to our operations if we don't have to move logs up island.

Jim Muress (JM): We lost time this summer due to heat and this fall due to rainfall. We will continue until Dec 23rd and start up January 5th weather permitting.

Keith Hunter (KH) spoke about Western Forest Products role in the blockade and thanked WFP for their role and response to the situation.

Satisfaction Survey areas to address:

6.4.1 – The reason this is back on the agenda is that we said that action items will be assigned to address all items that received a score of greater than three. Survey responses are coded as: 1 (excellent), 2 (good), 3 (satisfactory), 4 (poor), 5 (unsatisfactory).

The overall Objective is to maintain an effective public participation process. The only way that we can do this is to ensure that issues are brought forward and that we always have a mechanism to deal with any displeasure with the process. Specifically the area of the satisfaction survey that we are looking at is question 5 SWFM process. Overall we met the target but we had two PAG that did not rate the process well. We are not sure if it is through the SFM process or logging in general. There are a few themes within the comments and Erin will address these. I will take on as an action item to get the evaluation out earlier so that PAG can pin point the problems associated with the process.

The survey is anonymous and we thank all those who take the time to fill the form out.

Flag Action #2: WIWAG Satisfaction Survey Jennifer will make sure the next time we this survey more time is allotted to fill in the survey.

Specific – regarding Indicators 6.3.1 and 5.1.1

Erin Badesso (EB)

Some of the comments were that the indicators are weak for **6.3.1** and **5.1.1**.

5.1.1 Timber and Non-Timber benefits. EB looked at what other PAG groups have used. Reviewed indicator 5.1.1 (canned statement), basically the indicator describes how well Western Forest Products is doing. The EBITDA ratio is what people look at when investing, not just EBITDA. Erin recommends we add to the indicator instead of taking it out. What is being measured that is Non-Timber? We chose to focus on the timber aspect in this indicator. Erin reviewed list of ideas, local log sales, report on salaries/benefits, contractor payments, purchases in the local economy etc. and is open to suggestions. Discussion around measuring the economic benefit that goes back into the local economy.

How to quantify these measures? - Discussion about the wording of the standard. We do report out on the public concerns and comments in another indicator. There are three addendums to this indicator. We have tried to break this apart, due to the many aspects of the indicator, which may have weakened the initial indicator.

Indicator 6.3.1: Local Economy – Forestry Community well-being and Resilience

Erin presented some suggestions such as notification of road closures to recreational users, Road Safety hotline, information on view scapes etc. Erin asked for ideas on how to strengthen this indicator. There is an ebb and flow to this indicator and as a result Erin reports on what has happened. Request to report more specifically on where the logs are going. The value of sales into the company is reflected in the EBITDA.

Action #3 Indicators 6.3.1 and 5.1.1 recommends we add to the indicator instead of taking it out. Action relevant to what is being measured that is Non-Timber? Focus on timber aspect is in this indicator, ideas, local log sales, report on salaries/benefits, contractor payments, purchases in the local economy etc. WFP is open to suggestion on how to measure the economic benefit that goes back into the local economy better. EB will see how to quantify these types of variables, in regards to these indicators and report back to the group.

Note: Take a look at what all the indicators are and look how to improve upon where the logs are going and the value of sales into the company is reflected in the EBITDA.

This action item is a result of confusion between what is reported out on in each indicator. Good corporate PR so the community sees that they are benefitting from the company and the economic contribution. More indirect benefits lately, maybe not as transparent to the public as it once was.

Other Comments - General

The focus of WIWAG having a global component not just local was mentioned. Erin presented a document The State of Canada's Forests annual report for 2014 provides detailed information on Canada's forest resources and management. http://cfs.nrcan.gc.ca/publications?id=35713
Briefly reviewed reforestation chart, carbon emissions, Aboriginal, Employment indicators in the report. Lots of statistics are in the report as well. Looking at global information might be too broad to incorporate, but some national statistics might be workable. - Reviewed area

certification numbers and confirmed that Western Forest Products has a rigorous chain of custody process that proves to the auditor that the wood we are selling is certified. Pool of contractors Western Forest Products draws from: there are a small percentage of companies that are registered in Port Alberni, but their crews are in Port Alberni, Harvesting IPL 50%, Road Building IPL 50% and Star is local, Silviculture – seasonal not sure how many of these people are local. Not sure exactly of what percentage are local.

Action Item #4: Jim Muress will present the percentage of local employees as they relate to the contractors at the next meeting.

Climate Change Resistance - Erin will not speak to this tonight. Annette van Niejenhuis has agreed to come to a meeting in the future and it will be addressed at that time. She has the best information on how the DFA might change to adapt to climate change. Ideas are more than welcomed. Comment on cumulative impacts beyond WFP operations – making decisions today that will impact the future. Some information has predicted possible outcomes and we have picked species based upon these predictions.

Action Item # 5: Annette van Nieienhuis will present at our February 19, 2015 meeting on how the DFA might change to adapt to climate change. Ideas from PAG are more than welcome. We will ask Annette to comment on cumulative impacts beyond WFP operations - making decisions today that will impact the future

Indicator 3.2.A: Watershed Condition

This indicator replaces an earlier designation of "red and orange" listed watershed basins described in a watershed assessment performed every 10 years. EB reported on this at our last meeting. Glynnis has produced a 10 year landslide frequency and ways to log differently to reduce the amount of landslides. Due to the availability of new imagery, she was able to produce a report in 2013. Usually she only reports every three years. Bottom line is target was set at 5.6 for a NET area denominator which is equivalent to the 2.3 GROSS area denominator and we are at 5.5. Next year will be n/a because Glynnis will not do the work again until 2016. The n/a's were a result of the new indicator having data.

There was also comments about Old Growth management and EB will add this to a next meeting to help develop a better understanding of OGM

Action Item #6 – EB will bring OGMA's for perhaps the April meeting, presentation possible.

Communication Facebook site WFP for Bamfield Road Conditions

Kevin - first, bold step for Western Forest Products to utilize social media. Zach White has been hired to assist Amy Spencer, our media relations, to promote WFP's activities in social media. Create a feed and video footage on what to expect on the road. What does it look like from the cab of a logging truck? - Understanding driving from both perspectives. There is a sign posted with the twitter and Facebook information just before the end of the pavement on Bamfield Main.

Klanawa Project Update Erin Badesso

Aerial photo taken of a portion of the Klanawa. Western Forest Products went to some of the locations and took pictures of what it looks like now. For people who were not at the previous meeting and want to talk about the Klanawa, he is offering to get together offline, and review. Jennifer reiterated the presentation was very worthwhile and gave a lot of context.

Spine Trail Recreation – The meeting before last there was a general request what our harvest plan looks like in the next 5 years near the trail. It was posted on the WIWAG website that we would close the trail for a season while harvesting occurs. Harvesting map was reviewed. Stated that WFP would harvest next to or over the trail, and it was communicated back that the trail would be cleaned up after harvesting. The trail has been cleaned up and it is open to the public again.

-Discussion and clarification of the trail. Photos post harvesting and trail establishment shown to WIWAG.

Discussion on Soil and Water

The company has shared examples of environmental incidents WFP has had in the past. Tonight, Erin shared examples of minor environmental incidents relating to soil conservation and stream management reported to the Compliance and Enforcement wing of government. Discussion of the incidents, internal investigations, clean-up, and learnings were shared with WIWAG. A general discussion ensued on the Standard Operating Procedures (SOPs) deployed by WFP to conserve soil and water when timber harvesting.

Future Presentations

Tsilghot'in Nation (pronounced Sil-KO-tin) Supreme Court decision – Known as the Williams Case. There are some general themes, but still lots of opinions what it means. Keith spoke to a Chief Hugh Brakker who is willing to come in and present, but needs a few months' notice. Is the group interested in a presentation on this topic? Keith addressed the topic: Bases of appeal to the Supreme Court that title is not postage stamp title, title extends across their territory. Also establishes title outside of the treaty. Clarification - security of timber supply that Kevin spoke about earlier in the meeting is not a result of this decision. Keith reviewed the events that led up to the blockade that occurred in Nahmint. .

Presentation on the subject will be tabled until the next meeting, when more has been revealed. PAG was in agreement that this would be an excellent topic.

Thank you to Keith for his input and EB and KS will talk about how to present. Action #7: Keith Hunter has suggested that Chief Hugh Brakker could present the Tsilghot'in Nation (pronounced Sil-KO-tin) Supreme Court decision - Known as the Williams Case. There is great benefit to have it presented in a local context.
